INTRODUCTION

The 29th Annual General Meeting (AGM) was called to order by A/Prof Lim Lean Huat, President of the College, at 1.35 pm. He welcomed all the members present and thanked them for attending the AGM on a Sunday afternoon.

As there was no quorum, the President adjourned the meeting until 2.00 pm.

ITEM 1 PRESIDENT'S ADDRESS

- 1.0 The President reconvened the AGM at 2.00 pm. He reminded the House that a quorum had to be present to enable any part of the College Constitution to be amended, should the need arise.
- 1.1 The President briefed the House on the activities of the College during the past year and highlighted the significant events, which are reported in full details in the 29th Annual Report (1999-2000).

1.2 Report on the Extraordinary General Meeting (EGM)

1.2.1 The EGM was held on 24 September 1999. The following three resolutions were passed:

Resolution 1

That the College initiates the move to set up a Department of Family Medicine at the National University of Singapore

Resolution 2

That the College spearheads the fund raising towards a target sum of S\$3 million for the Endowment Fund for the Chair in Family Medicine.

Resolution 3

"That a donation of at least S\$250,000 be made by the College from its existing funds to the proposed Endowment Fund for the Chair in Family Medicine at the National University of Singapore."

- 1.2.2 The President reported on the developments since the EGM. Members of the 17th Council met with Prof SS Ratnam, then Director of the Graduate School of Medical Studies and Prof Tan Chorh Chuan, then Dean of the Faculty of Medicine, to further discuss the above issues. The plan was to set up a Chair in Family Medicine within the Department of Community, Occupational and Family Medicine (COFM) at the university in the first phase, and then to set up the full department in the second phase within an agreed time period.
- 1.2.3 After the meeting with Prof SS Ratnam and Prof Tan Chorh Chuan, members of the 17th Council then met with Prof Lee Hin Peng, Head of the Department of COFM. They were taken aback and confused by Prof Lee's reaction to the College's plan to set up a Chair in Family Medicine. Prof Lee explained to the Council Members how a Chair at the Department of COFM would be set up. The sum of S\$1 million would have to be forwarded by the College to the Bursar's Office at the university and a committee would be appointed to set up the Chair. Prof Lee explained to the Council Members that this would be a Research Chair within the Department of COFM and that the position could be

- filled by anyone, not necessarily a local candidate. According to Prof Lee, this was in line with the emphasis on (i) Research and (ii) Teaching.
- 1.2.4 The President reported that as a result of the meeting with Prof Lee, the above position was not in line with the 17th Council's sentiments nor the three resolutions passed by at the EGM held on 24 September 1999. Therefore, he had to revert to the House at the Annual General Meeting. In the interim, the 17th Council decided that a Research Centre would be set up at the College, directed by A/Prof Goh Lee Gan. This is the latest situation at the moment since the EGM regarding the developments in plan to set up the Chair and Department in Family Medicine.

1.3 Visit of the Minister of Health

- 1.3.1 The President reported that the College received a visit from Mr Lim Hng Kiang, Minister of Health, and senior officials from the Ministry on 15 October 1999. Members of the 17th Council and staff of the Secretariat met with the delegation. The Minister was briefed on the work of the College and its role, especially in the accreditation of Continuing Medical Education (CME) and recognition of Family Physicians/GPs who have undergone further training in Family Medicine. The Minister reiterated his support to the College and suggested that a scheme be set up to give doctors recognition of their achievements and level of CME participation, eg, the one star, two star, three star doctor.
- 1.3.2 The Council also brought up the issue of the restrictive use of certain drugs and medicine by FPs/GPs. This issue was subsequently discussed at a meeting between Council Members and the Medical Advisory Committee (MAC) on 14 February 2000.

1.4 7th Scientific Conference and 8th Meditech Exhibition

- 1.4.1 The 7th Scientific Conference and 8th Meditech Exhibition was held on 25-26 September 1999, on *Family Medicine: Facing Demographic Change*. This event took place at the College of Medicine Building.
- 1.4.2 The highlights of the Opening Ceremony of the conference included the 17th Sreenivasan Oration, delivered by Dr Tan Cheng Bock on the topic of *Medicine* and *Politics Do They Mix?* An Honorary Fellowship was awarded to A/Prof Chee Yam Cheng in recognition of his contribution to Family Medicine and his support to the College in developing the Master in Medicine (Family Medicine) degree. The Albert and Mary Lim Award was awarded to Dr Arthur Tan and Dr Richard Ng Mong Hoo for their long and dedicated service to the College.

1.5 The College Website

1.5.1 The President reported on the launch of the College Website on 18 July 1999. Members are able to do CME on line and have links to other useful and important websites. He especially thanked Dr Lee Kheng Hock for his contribution to the project. Since the launch of the website, however, there have been hitches in the maintenance of the site. Dr Lee KH will explain later in his report to the House.

1.6 Graduate Diploma in Ultrasonography (O&G)

1.6.1 The College and the Graduate School of Medical Studies successfully launched the Graduate Diploma in Ultrasonography (Obstetrics and Gynaecology) on 18 July 1999. The aim is to provide the necessary training to FPs/GPs to use ultrasonography appropriately and competently as a diagnostic tool in the primary care setting.

1.7 Regular CME

- 1.7.1 The 4th Annual Surgical Update for Family Practice was successfully held on 4-5 March 2000. The inaugural Minor Surgical Procedures Course, which was co-organised with the Singapore General Hospital, was held the weekend after on 11-12 March. This course was heavily oversubscribed. Given the evident demand for such training, the College aims to hold this course on a regular basis.
- 1.7.2 The President also reported that members from the respective east and west health care clusters also met with representatives from the College. They are keen to involve the College in their respective CME programmes. The House will be kept informed of further developments on this aspect, especially where FPs/GPs stand in the health care cluster scenario.

1.8 The Graduate Diploma in Family Medicine (GDFM)

- 1.8.1 The President reported that the Graduate Diploma in Family Medicine is to be launched on 1 July 2000. The course is to train FPs/GPs to practise Family Medicine at an *enhanced* level which is able to meet the needs of the young child, the adult and the elderly, with emphasis on diagnostic and management skills in the various clinical disciplines.
- 1.8.2 Publicity flyers and registration details for the course were sent out to members and the wider medical community in early May 2000. The course syllabus of the GDFM has been forwarded to Prof Lee Eng Hin, Director of the Graduate School of Medical Studies. He has subsequently sent it to the Vice Chancellor of the university. This was confirmed in a letter dated 27 April 2000 addressed to the President of the College from Prof Lee EH.
- 1.8.2 The President also reported that he has written to Dr Chen Ai Ju, Director of Medical Services, Ministry of Health, about the GDFM. He has since received a letter from Dr Arthur Chern, signed on behalf of Dr Chen Ai Ju, in support of the course. The Ministry has also advised the College to write to the Singapore Medical Council to obtain recognition of the GDFM as a registrable qualification.

1.9 College activities in the region

1.9.1 The President reported that the College has continued its work in helping neighbouring countries such as Myanmar and Indonesia develop the discipline of Family Medicine in their respective countries.

1.10 Acknowledgement to staff

1.10.1 The President expressed his thanks and appreciation to Ms Yvonne Chung, Administrative Manager and the Secretariat staff for their work and administrative support to the Council and to College members. The amount of work achieved during the past year would not have been possible without their contribution and hard work.

ITEM 2 MINUTES OF THE 28th AGM HELD ON 23 MAY 1999

2.1 The House went through the minutes of the 28th AGM held on 23 May 1999. There was one amendment to page 8, para 1.3.1.1. Dr Cheong Pak Yean's position should be President of the Singapore Medical Association (not Singapore Medical Council). The paragraph should read:

"A team of three doctors comprising Dr Alfred Loh in his capacity as President of the College, Dr Cheong Pak Yean, President of the Singapore Medical Association, and A/Professor Goh Lee Gan, representing the Department of Community, Occupational and Family Medicine, National University of Singapore, formed the Singapore International Foundation's Specialist Team on Family Medicine".

2.2 There were no other amendments. The minutes of the 28th AGM held on 23 May 1999 were proposed for adoption by Dr Alfred Loh Wee Tiong and seconded by Dr Lawrence Ng Chee Lian. There were no objections.

ITEM 3 MATTERS ARISING FROM THE MINUTES OF THE 28th AGM HELD ON 23 MAY 1999

3.1 <u>SMC-CME Programme</u>

- 3.1.1 Dr Chong Swan Chee asked why the Singapore Medical Council took over the administration of the SMC-CME programme when the College was more than adequately carrying out this function on behalf of the SMC-CME Committee?
- 3.1.2 Dr Richard Ng and Dr Alfred Loh explained that the SMC wanted a national implementation of an on-line system which would necessarily mean that the administration had to be carried out by the SMC. However, the College will continue to be actively represented in the SMC-CME Committee and would retain its powers to accredit CME that is relevant for Family Physicians/GPs.

3.2 College Premises

3.2.1 Dr Alfred Loh reported that the commercial monthly rental of almost \$\$9000 paid by the College to the Ministry of Health is a heavy financial burden on the College's finances. Dr Alfred Loh has been in discussions with the Permanent Secretary (Health), Mr Moses Lee who has clearly indicated that the Ministry is seeking ways to enable the College to stay in its premises at the College of Medicine Building. One way to assist was by reducing the monthly rental to \$\$6500.

3.3 Graduate Diploma in Ultrasonography (O&G)

- 3.3.1 Dr Chong Swan Chee commented that doctors have to be cautious when using ultrasound as diagnostic tool as they could be sued for incorrect use.
- 3.3.2 Dr Cheong Pak Yean commented that the issue of suing doctors applies to the medical profession as a whole. Doctors will be judged according to the level to which they are trained.
- 3.3.3 Dr Alfred Loh, in his capacity as Chairman of the Ultrasound Committee explained the rationale behind setting up the Graduate Diploma in Ultrasonography (O&G). Many Family Physicians/GPs were already using ultrasound in their practice. Ultrasound machines are easily available and there are no restrictions on their purchase. The "training" that currently exists consists of weekend courses conducted by the ultrasound machine companies. This is not adequate. Therefore, the College Council decided that it would be better to have proper and structured training to enhance the level of practice. This initiative was well supported by the Graduate School of Medical Studies, NUS and the O&G Department at the National University Hospital.
- 3.3.4 The rigorous syllabus of the Graduate Diploma in Ultrasonography (O&G) course is of international standard, recognized by the Singapore Medical Council, and is the first of such certified courses at the postgraduate level in the region.

3.4 College Website

- 3.4.1 Dr Lee Kheng Hock updated the House on the status of the College Website. He explained that there are glitches in its maintenance due to lack of funding. Briefly, the maintenance of the website was first carried out on a complimentary basis by a company called Sembawang Media. The company then withdrew from the project. The College sourced for a second and smaller company, but the company closed down. The College then sought the assistance of the Medical Informatics Programme (MIP) at NUS, which is backed by the National Computer Board. However, MIP has sold its entire project (in the which the College's website is an item) to a company called Health Answers International. This company has agreed to maintain the College Website. However, the deal between MIP and Health Answers fell through, thus College Website has been left in "limbo".
- 3.4.2 Presently, the college has sought the assistance of the Singapore Medical Association to maintain the online CME and FMTP components of the Website functioning.
- 3.4.3 The options facing the College is, either to maintain the website internally, but this would involve a lot of resources, technical expertise and money, or, to accept the offer of Health Answers International to host the website on a complimentary basis. Given the previous negative experiences with collaborating with commercial companies, the College is now more cautious in adopting this alternative.

3.5 College Library

- 3.5.1 Dr Chong Swan Chee commented that the College Library is limited in what it could offer in terms of facilities and resources
- 3.5.2 Chairman explained that the College Library would be upgraded. However, this is delayed as the part of the premises that it occupies is going to be renovated by the Ministry of Health. As such, the College is not able to proceed with its upgrading.
- 3.5.3 Dr Chong Swan Chee was invited to be a member of a committee involved in maintaining the library. He declined the invitation.

ITEM 4 MINUTES OF THE EXTRAORDINARY GENERAL MEETING (EGM) HELD ON 24 SEPT 1999

- **4.1** The House went through the minutes of the Extraordinary General Meeting (EGM) held on 24 September 1999. There were no amendments.
- 4.2 The minutes of the Extraordinary General Meeting (EGM) held on 24 September 1999 were proposed for adoption by Dr Alfred Loh and seconded by A/Prof Goh Lee Gan.

ITEM 5 MATTERS ARISING FROM THE MINUTES OF THE EGM HELD ON 24 SEPT 1999

- 5.1 Chairman updated the House on the latest developments on the proposed Department of Family Medicine since the EGM held on 24 September 1999. The update is contained in para 1.2 of these minutes.
- 5.2 Dr Alfred Loh updated the House further on the developments of the Finance Committee for the Department of Family Medicine. Dr A Loh has been tasked to head this committee with Dr Wong Heck Sing as Advisor. Dr Loh explained that given the economic situation, it was not timely to launch the appeal for funds. Through his discussions with various practicing doctors, however, he has already secured a S\$1 million pledge. Dr Loh encouraged the Council and members of the College to seek private appeals. He is confident that once the fund raising begins, the sum of S\$3 million is attainable in two years.
- 5.3 Dr Loh reiterated the Chairman's report on the developments since the EGM held on 24 September 1999. Given the facts found in paragraphs 1.2.3 and 1.2.4 above, the idea of creating a Chair in Family Medicine at the Department of COFM, NUS has been shelved and the push is now for a Department of Family Medicine.
- 5.4 Dr Jonathan Pang enquired whether the Dean has been informed of the change in events as stated above. A/Prof Goh Lee Gan reassured the House that through his discussions, the Dean, Prof Lee Eng Hin and also the Permanent Secretary (Health), both support the proposed move towards setting up a Department of Family Medicine.

ANNUAL REPORT OF THE 17TH COUNCIL FOR THE YEAR ENDED 31 MARCH 2000

6.1 Search for WONCA CEO & Secretariat

- 6.1.1 Chairman updated the House on the College's bid to host the Secretariat of the World Organization of Family Doctors (WONCA) and the nomination of Dr Alfred Loh as the new CEO of WONCA. One of the conditions of relocating the WONCA Secretariat is that it must be linked to or co-located at a college that holds full membership with WONCA.
- 6.1.2 WONCA had received 5 applications for the position of CEO and two were shortlisted: Dr Alfred Loh and the candidate from the University of Florida, USA. The American bid has a backing of US\$100,000. But this would go to supplement the CEO's salary should the candidate be successful and not benefit WONCA directly.
- 6.1.3 One advantage that Singapore may have over the USA, is that it is very likely that WONCA can be incorporated in Singapore. Due to the technicalities in various countries, WONCA, since its establishment in the early 1970s, has never been incorporated. Therefore, it is not a legal entity. Dr Alfred Loh has enlisted the assistance of Arthur Andersen to incorporate WONCA, and to have it registered with the Registrar of Companies as a company limited by guarantee.
- 6.1.4 Dr A Loh is also in the process of obtaining tax-exempt status for WONCA, and enlisting the help of the Economic Development Board (EDB) and pharmaceutical companies to ensure that Singapore is the favoured location for WONCA. If the College is successful in its bid, it would be prestigious to host a world body in Singapore, which would undoubtedly bring international focus on the country, and raise the profile of the College and the discipline of Family Medicine.

6.2 Report of the Board of Censors (Refer to pp 31-33 of 29th Annual Report 1999-2000)

- 6.2.1 Chairman reported that the publicity for the Graduate Diploma in Family Medicine (GDFM) has been announced and flyers sent to College members.
- 6.2.2 The Censor-in-Chief, Dr Lau Hong Choon, updated the House on the details and syllabus of the GDFM. The aim is to provide an intermediate qualification between the MBBS and MMed(FM) degrees. All trainers for the course are at least MMed(FM) holders. The College is in the process of obtaining approval from the Singapore Medical Council for the GDFM to be registrable and displayable qualification.
- 6.2.3 Dr James Chang suggested that all GDFM trainees should be College Members.
- 6.2.4 In relation to this suggestion, A/Prof Cheong Pak Yean suggested that a Family Physician Register could be set up once a critical mass of GDFM and MMed(FM) holders has been achieved.

- 6.2.5 At this juncture, A/Prof Cheong PY enquired about the current status of the MCGPS/MCFPS holders.
- 6.2.6 Dr Lau Hong Choon explained that the MCGPS/MCFPS qualification is the 'property' of the College and the MMed (FM), which is based on the MCGPS, has superceded this.
- 6.2.7 A discussion then ensued on the awarding of the proposed "new" MCFPS to MMed(FM) holders as a professional award and something similar to a joint degree. Council has discussed this proposal. If agreed, the new MCFPS will only be awarded to MMed(FM) holders who are College members, and would provide a link between the College and the university, which now awards the MMed(FM) degree.
- 6.2.8 Dr Alfred Loh suggested to the Censors' Board that the awarding of the new MCFPS should not be an automatic procedure, but should be based on something substantial. For example, the MCFPS should be awarded only after "x" number of years in research and teaching, or the person must have contributed substantially to the College.
- 6.2.9 A/Prof Goh Lee Gan commented that recognition of the MCFPS is endorsed on page 3, section 4 of the College constitution. Reviving the MCFPS is a means to getting doctors with the MMed(FM) to join the College, and that future Fellows will have to have the MCFPS qualification.
- 6.2.10 On other Censors' Board matters, Dr Lau Hong Choon reported that Prof SS Ratnam has been nominated for an Honorary Fellowship and that Dr Lim Kim Leong has been nominated for the Albert and Mary Lim Award.
- **Report of the CME Committee**(Refer to pp 34-37 of 29th Annual Report 1999-2000)
- 6.3.1 Dr Richard Ng, Chairman of the CME Committee, highlighted the success of the 1st Minor Surgical Procedures (MSP) course for Family Physicians. This was oversubscribed, indicating the demand for such hands-on training.
- 6.3.2 A/Prof Cheong PY suggested that the MSP course could be a component part of the GDFM course and that places could be reserved for GDFM trainees in future courses.
- 6.3.3 In relation to the new administration of the national CME programme by the Singapore Medical Council, Dr Soh Cheow Beng sought clarification on the administrative fees payable to the College by the SMC-CME Committee when the College used to administer this programme.
- 6.3.4 Dr Richard Ng explained that there is still some S\$3,600 in the account, which is not even enough to pay the College for the administration of the defunct SMC-CME, programme since it ceased on 31 December 1999.
- 6.3.5 There were no further comments or objections. The House thanked Dr Richard Ng for his report.

Family Medicine Teaching Programme(Refer to p 38 of 29th Annual Report 1999-2000)

- 6.4.1 A/Prof Goh LG reported that the Family Medicine Teaching Programme (FMTP) continues to be one of the core activities of the College. The structure of the FMTP has been changed to include a more interactive element. Instead of the didactic 8 lectures per module, each module now consists of 4 workshops centred on case studies and discussions. The course materials are now on the website which trainees are able to download at their convenience.
- 6.4.2 There were no further comments or objections. The House thanked A/Prof Goh LG for his report.

6.5 Report of the Undergraduate Teaching Committee (Refer to pp 39-40 of 29th Annual Report 1999-2000)

- 6.5.1 The College continues to assist the National University of Singapore in the training of medical students. Dr David Lim, Chairman of the Undergraduate Teaching Committee, apologized for the omission of A/Prof Lim Lean Huat's name on the list of clinical teachers.
- 6.5.2 Dr David Lim welcomed the increased number of tutors, which means that more medical students can benefit from the clinical postings.
- 6.5.3 A/Prof Chan Nang Fong gave some positive feedback from the students. They have commented that they can see the value of Family Medicine in contrast to hospital medicine. A/Prof Chan NF also encouraged more FPs/GPs to come forward and be tutors for the GP Postings.
- 6.5.4 Dr Lau Hong Choon reported that a specialist colleague (Dr Yu Su Ling) commented that only FPs/GPs could teach and give students exposure to "whole person medicine".
- 6.5.5 A/Prof Goh LG gave his appreciation to the adjunct teachers, namely A/Prof Lim Lean Huat, A/Prof Cheong Pak Yean, A/Prof Chan Nang Fong and Dr Moira Goh for their commitment and contribution to undergraduate teaching. Their enthusiastic support have always ensured a good turnout of students and they are role models for up and coming younger tutors.
- 6.5.6 The House showed its appreciation to all tutors of the FMTP and thanked Dr David Lim for his report.

Report of the Research and Information Committee (Refer to p 41 of 29th Annual Report 1999-2000)

- 6.6.1 Dr Kwan Yew Seng, Chairman of the Research and Information Committee updated the House on the Achilles Research Project on foot diseases in Singapore. The results were presented at the College's Scientific Conference held in September 1999.
- 6.6.2 Dr Kwan reported that there might be two more projects in the pipeline involving his committee. He and Dr Lee Kheng Hock are currently in discussion with the relevant pharmaceutical companies.

6.6.3 There were no further comments or objections. The House thanked Dr Kwan Yew Seng for his report.

6.7 Report of the Publications Committee (Refer to p 42 of 29th Annual Report 1999-2000)

- 6.7.1 Dr Tan Chee Beng, Honorary Editor reported that the Singapore Family Physician Journal has a thematic approach in both organization and content. The focus is on practical approaches and clinical updates. The College Mirror continues to be a source of updating members on the activities of the College.
- 6.7.2 Dr Tan CB encouraged more members, especially the pool of MMed(FM) holders to contribute articles.
- 6.7.3 There were no further comments or objections. The House thanked Dr Tan Chee Beng for his report.

6.8 Report of the Practice Management Committee (Refer to p 43 of 29th Annual Report 1999-2000)

- 6.8.1 Dr Matthew Ng reported on behalf of Dr Tan See Leng, Chairman of the Practice management Committee on the various activities that members of this committee were involved in. He reported that it was an honour for the College to be asked by the SAF to visit and review their medical centers and to give recommendations to improve the level of primary care in the SAF.
- 6.8.2 Dr Tan See Leng and Dr Lawrence Ng also represented the College in the Medical Technology and Standards Committee under the Productivity and Standards Board. Both members have been active in giving feedback on medical devices and equipment.
- 6.8.3 There were no further comments or objections. The House thanked Dr Tan See Leng for his report.

6.9 Report of the Finance Committee (Refer to p 46 of 29th Annual Report 1999-2000)

- 6.9.1 The House went through the report. Despite generating income from numerous activities and chalking up a gross income of just over \$\$300,000, the annual accounts showed a financial deficit of some \$\$42,000. However, this deficit is much lesser than that of 1999 when the deficit was some \$\$95,000. The largest expenditure items continue to be the commercial rental of the premises amounting to some \$\$80,000, staff cost amounting to over \$\$86,000 and outstanding subscription income from members, with some stretching over a number of years.
- 6.9.2 There were no further comments or objections.
- 6.9.3 The House thanked Dr Richard Ng Mong Hoo for his report.

6.10 Report of the 7th Scientific Conference & 8th Meditech Exhibition (Refer to pp 44-45 of the 29th Annual Report 1999-2000)

6.10.1 Dr Kwan Yew Seng, Chairman of the Organising Committee for the 7th Scientific Conference & 8th Meditech Exhibition, expressed his appreciation to the Council, Organising Committee and Secretariat staff for their assistance in the planning and execution of this event.

6.11 Adoption of the Reports

6.11.1 With no further comments, the Report of the 17th Council and the respective reports of the Standing Committees were proposed for adoption by Dr Alfred Loh and seconded by A/Prof Cheong Pak Yean.

iTEM 7 <u>AUDITED ACCOUNTS FOR THE YEAR ENDED 31 MARCH 1999</u> (Refer to pp 47-55 of the 29th Annual Report 1999-2000)

- 7.1 The House went through the Statement of Accounts for the year ended 31 March 2000.
- 7.2 With no further questions from the floor, the audited accounts for the year ended 31 March 2000 were proposed for acceptance by Dr Soh Cheow Beng and seconded by A/Prof Cheong Pak Yean.

ITEM 8 APPOINTMENT OF AUDITOR AND HONORARY LEGAL ADVISOR

- 8.1 Chairman recommended to the House to keep the appointment of Messrs V P Kumaran & Co as the Auditors and Messrs Lim Chor Pee and Partners as the Honorary Legal Advisors.
- **8.2** The House accepted the above recommendation.

ITEM 9 NOMINATION AND ELECTION OF HONORARY FELLOWS & THE ALBERT AND MARY LIM AWARD

- 9.1 The Censors' Board has recommended the nomination of Professor SS Ratnam as an Honorary Fellow of the College for his support and contribution in promoting Family Medicine as a distinct discipline. Professor Ratnam was instrumental in setting up the MMed (FM) degree and the Graduate Diploma in Basic Ultrasonography (O&G). He is an avid supporter of the College.
- **9.2** The House approved the nomination of Professor Ratnam for an Honorary Fellowship.
- 9.3 The Censors' Board has recommended the nomination of Dr Lim Kim Leong for the Albert and Mary Lim Award. Dr Lim KL was instrumental in the development of the College over 20 years ago. He is one of the founding members and is a past Censor-in-Chief. Family Medicine is his passion and Dr Lim KL played a major role in the setting up of the Family Medicine Teaching Programme. Dr Lim was one of the committee members who successfully

- organized the 10th WONCA World Conference in 1983, which was then the largest medical conference held in the region with some 2500 participants.
- 9.4 Dr Alfred Loh voiced his personal support for the nomination of Dr Lim KL and praised his contribution to the College.
- 9.5 The House accepted the nomination of Dr Lim Kim Leong for the Albert and Mary Lim Award.

ITEM 10 GRADUATE DIPLOMA IN FAMILY MEDICINE

10.1 The report to the House on the Graduate Diploma in Family Medicine has been covered under the President's Address, paragraph 1.8.

ITEM 11 DEPARTMENT OF FAMILY MEDICINE

11.1 The report on the Department of Family Medicine has been covered under the President's Address, paragraph 1.2.

ITEM 12 CHANGES TO THE COLLEGE ENTRY CRITERIA

- 12.1 Chairman reminded the House that the entry criteria can only be discussed at this AGM; they cannot be amended nor changed, as there is no quorum.
- 12.2 A discussion ensued on the restrictive nature of the College's entry criteria. Feedback from joining members indicated that finding a proposer and seconder who were at least Ordinary Members of the College was quite difficult, especially for the younger generation of doctors as they do not know many, and in some cases, any, such members at all.
- 12.3 A suggestion was made that College should consider accepting proposers and seconders who are doctors registered with the SMC, not necessarily Ordinary Members of the College. This would certainly enable potential applicants to apply more quickly.
- **12.4** A/Prof Cheong PY suggested that administratively, if potential applicants could not find a proposer and seconder, Council members could fulfill this role.
- 12.5 The issue of life membership was also discussed. Some members were in favour of this move, but suggested that the fees need to be deliberated.
- 12.6 Dr Alfred Loh supported the opening up of the entry criteria and said that he would table this at the next AGM.

ITEM 13 ANY OTHER BUSINESS

13.1 Use of the term "Consultant Family Physician"

13.1.1 A/Prof Cheong PY brought up the issue of the promotion and use of the term "Consultant Family Physician" for FPs/GPs with the relevant qualifications and

- experience. His standpoint was that recently, 3 Family Physicians have been promoted to consultant level within the government service.
- 13.1.2 Dr Alfred Loh commented that this is in line with the College's wish to have a Family Physician Register to recognize doctors who have pursued continued training at different levels. The idea would be to have in ascending order; Family Physician, Senior Family Physician, Consultant Family Physician and Senior Consultant Family Physician.
- 13.1.3 A/Prof Goh LG highlighted 3 points for the House to consider:
 - i. Would the use of this term create a paradigm shift and create a new entity of FP/GP "specialists"?
 - ii. What level would be considered as a benchmark for a Consultant Family Physician? Would it be doctors with a Fellowship?
 - iii. Who is a "Family Physician"? A GDFM Holder?
- 13.1.4 A discussion ensued on the above points and on implications of the use of the term "Consultant Family Physician". Politically, it may be not be a tactical nor timely move as it could be perceived as Family Medicine claiming itself to be a "Specialty" per se. Setting up the Family Physician Register first would be more appropriate.
- 13.1.5 Dr Lawrence Ng commented that a register is needed, as the FP/GP community is heterogeneous. It would distinguish those FPs/GPs who have undergone further training and medical education, ie, be the "quality marker" for the FP/GP.
- 13.1.6 Dr Soh Cheow Beng commented that Family Medicine is a specialty in some countries such as the USA. He suggested that Singapore should follow a similar model. A/Prof Cheong PY supported this suggestion.
- 13.1.7 Chairman concluded the discussions by proposing that the Family Physician Register is an issue that the Council would need to deliberate further.

13.2 The Implications of the Health Care Clusters for FPs/GP

- 13.2.1 Some members on the floor voiced their anxiety on the implications of the health care clusters on the GP community. Many FPS/GPS are confused about the recent MOH changes.
- 13.2.2 A/Prof Goh LG suggested that we should meet representatives from the Ministry and collectively voice our concerns. It was also suggested that the College Council meet with the Cluster Heads to discuss the vertical integration of healthcare and what it means for the FP/GP.
- 13.3 With no other matters to discuss, the Chairman called the 29th Annual General Meeting to close at 5.10pm. Dr Lawrence Ng proposed a vote of thanks to the Chair, seconded by Dr Alfred Loh.

2.0 COLLEGE AND COUNCIL ACTIVITIES

Graduate Diploma in Family Medicine

- 2.1.1 In March 2000, the idea of having a graduate diploma in family medicine (GDFM) was mooted by the College. It was very well received by both Prof Lee Eng Hin (Director, GSMS) and the Family Medicine Committee of the GSMS.
- 2.1.2 A paper on the GDFM was presented to the GSMS and forwarded to the Senate of the National University of Singapore. The College will run the GDFM programme. There is an examination at the end of the 2-year programme and the College and the GSMS will jointly award the diploma.
- 2.1.3 The GDFM committee is chaired by the Censor-in-Chief of the College, Dr. Lau Hong Choon. A/Prof Cheong Pak Yean was appointed by the Council as the Course Director. The programme was officially launched on 1 July 2000.

2.2 College Certified Family Physician Register

- 2.2.1 A proposal to set up a register of College certified family physicians was carefully considered by the Council. The concept of the proposal was to have a register of family physicians that are committed to quality assurance, training and upgrading of professional skills and knowledge.
- 2.2.2 The Censors' Board was tasked to study the proposal. It was felt that the register would have very significant long-term considerations. Both the Council and the Censors' Board were mindful of the implications of such a register.
- 2.2.3 It was suggested that the register would be an internal one and administered by the College. Participation would be voluntary and the register will be promoted as a benchmark of competence in family medicine. The objective is to promote quality assurance and improve the professional standing of family physicians. Criteria for entry to such a register would be carefully studied before implementation of the register.
- 2.2.4 The conclusion was that such a register would be useful and beneficial to our profession. The register will only be implemented in the near future after all the pros and cons are carefully studied.

2.3 MCFP(S) by Collegiate Membership

2.3.1 The Censors' Board proposed that the Diplomate Membership (MCFP) should be awarded to College members who have attained the Masters of Medicine (Family Medicine) qualification.

- 2.3.2 Criteria for admission to the Diplomate Membership is still under study and would include the following:
 - i. Candidates must be members of the College for at least 2 years.
 - ii. Candidates must show commitment to professional development by satisfying SMC's requirement for CME.
 - iii. Candidates must show evidence that they are active in academic work and College activities.

2.4 Restricted Prescription of Drugs

- 2.4.1 In response to concerns raised by members, the College wrote to the Medical Advisory Committee (MAC) expressing our disquiet over a recent trend whereby certain new drugs are registered on condition that they are not allowed to be prescribed by family physicians.
- 2.4.2 The Council and members of the MAC held a meeting to discuss the issue. During the meeting, the following points were conveyed to the MAC:
 - i. There should be prior discussion and consultation with the College before such decisions are finalised.
 - ii. The process of evaluation and decision-making should be made transparent.

MAC reassured the Council that the College would be consulted in the future.

- 2.5 Family Medicine Fellowship by Assessment Programme (FMFP)
- 2.5.1 The second intake of the FMFP started their 2-year programme in April.
- 2.5.2 The first intake of 8 candidates successfully completed their programme and was awarded the FCFPS.

2.6 CFPS-WHN CME On-Line Programme

- 2.6.1 The College was tasked by the SMC-CME committee to develop CME programmes for family physicians in anticipation for the advent of compulsory CME. Among the many concerns was the situation of long work hours of the family physicians. The objectives of developing our own electronic on-line programme were:
 - i. Allow busy family physicians to do CME at their own time and convenience.
 - ii. Leverage on information technology.
 - iii. Enable the College to ensure the relevance, comprehensiveness, manageability as well as the quality of the materials.
- 2.6.2 The College went into partnership with World Health Network (WHN) to jointly develop the programme. WHN is an international medical software company, which will provide the funding and handle the technical aspects of the project.

2.6.3 This programme is in the final phases of development and will be launched in the third quarter of 2001.

2.7 The Albert and Mary Lim Award (AMLA) and Honorary Fellowship 2001

- 2.7.1 The Board of Censors recommended that Dr Lim Kim Leong be awarded the AMLA in recognition of the many years of contribution and good work that he had done for the College and the development of family medicine in Singapore.
- 2.7.2 Professor SS Ratnam will be awarded the Honorary Fellowship in 2001. Prof Ratnam is an avid supporter of the college. Although he is not a family physician, he is a visionary constantly advocating the importance of primary health care and the need to have well trained family physicians. As the Director of the Graduate School of Medical Studies, he was instrumental in bringing the Master of Medicine (Family Medicine) programme into fruition despite the many obstacles that were placed in its path.
- 2.8 <u>Feedback to Ministry of Health on Medical Manpower Projections and</u>
 Changes to the SMC registration
- 2.8.1 The College was invited by the Director of Human Resource, MOH to express our views on the projected medical manpower needs.
- 2.8.2 We conveyed our opinion that the shortage of doctors was more perception than reality due to the sub-optimal deployment of medical manpower. The balance of the number of doctors in the private and public sector are dependent on many "push and pull" factors. Among these are policies, salary disparities and working conditions.
- 2.9 Bidding to host the WONCA World Conference 2007
- 2.9.1 The College Council decided that we should make a bid to host the WONCA World Conference 2007. Dr Tan See Leng was nominated to form the organizing committee, which will also be the pro-tem organizing committee. The bidding will take place at the WONCA World Conference 2001 in Durban, South Africa.
- 2.10 8th Scientific Conference and Medical Update
- 2.10.1 In view of the success of the annual surgical updates, it was proposed that we should have a similar programme for internal medicine. Since the College will be organizing the 8th Scientific Conference in August 2001, it was suggested that we use medical updates as the theme of the conference. If proven successful, medical updates may be held on an annual basis.
- 2.10.2 Dr. Matthew Ng was appointed as the chairman of the organizing committee.

2.11 CFPS Website Development

- 2.11.1 The Medical Informatics Programme which has been hosting our website, has since scaled down its operations and ceased to maintain our website.
- 2.11.2 The Singapore Medical Association is currently maintaining our website at a cost of \$420 per month.

2.12 5th Annual Surgical Update

- 2.12.1 This annual event was held over 2 weekends in February 2001. It was very well received by participants and is fast becoming a landmark in the CME calender.
- 2.12.2 80 participants attended the 2nd Minor Surgical Procedures Course For Family Physicians, which was held on 17, 18 and 25 February, 2001 at the Singapore General Hospital.

2.13 The Independent Department of Family Medicine

2.13.1 The proposal to set up an independent department in family medicine at the National University of Singapore is still in the planning phase. Plans detailing the budget, organizational structure, staffing requirements are being worked out before submission to the Dean of the Faculty of Medicine.

2.14 Medical Indemnity Insurance and Issues Concerning Family Physicians

- 2.14.1 There were concerns over family physicians performing low risk procedures being made to pay premiums disproportionate to the risk involved as a result of unclear definition of terms.
- 2.14.2 The terms "cosmetic" and "procedure" were not properly defined and may create confusion when premium is determined. Furthermore medical indemnity insurance companies are based overseas and may not use culturally appropriate models to assess risk.
- 2.14.3 These issues were raised by members to the College Council. The CFPS is currently engaged in discussions with the medical indemnity insurance companies to clarify such matters.

2.15 Visitors to the College

- 2.15.1 A delegation of 4 family physicians from the Myanmar Medical Association were sponsored for a study tour to Singapore to observe the Master of Medicine (Family Medicine) Examinations from 9-17 October 2000. The cost of the sponsorship was donated by a Council Member of the College.
- 2.15.2 A delegation of 6 senior doctors and officials of the Myanmar Medical Association visited our College in August 2000. They were briefed on the development of Family Medicine in Singapore. The MMA is working on

developing a GP Section in their association and requested the help of our College.

2.16 FCFP (Aged Care)

- 2.16.1 Many MMed (FM) graduates are working in community hospitals that provide aged care. The Censors' Board proposed to the Council that we should use the FCFP as a form of recognition to further their professional development.
- 2.16.2 A modified programme based on our present FCFP programme was developed and presented to the Council. The Council accepted this and the first intake of candidates for this programme would be held in July 2001.

2.17 WONCA Secretariat

2.17.1 Dr. Alfred Loh, Past President of the College and Council Member is selected to be the Chief Executive Officer of WONCA. The WONCA Secretariat will move from Melbourne, Australia to Singapore on 1 May 2001. Ms Yvonne Chung, our Administration Manager, will be joining the WONCA Secretariat.

1 INTRODUCTION

2000/2001 was a historic year of firsts in the academic history of the College. It saw the launch of the first Graduate Diploma Of Family Medicine (GDFM) programme, as well as the successful exit of the first batch of Fellows by Assessment. The Council also approved the Family Medicine Fellowship Programme (Aged Care).

Many of the guests present were instrumental in the development of Family Medicine.

However what belies the significance of the event was that the College had begun to bridge the academic gap among GPs and medical officers. It has been recognised that the MMed (Family Medicine) may not address the general needs of busy GPs and medical officers who may not have the time or intention to pursue the more arduous

Masters Programme but nevertheless are able to take a useful Family Medicine Programme leading to a diploma.

The programme started with 28 tutors with the MMed (FM) qualification and 48 "trainees". It was led by A/Prof Cheong Pak Yean, Director of the programme with A/Prof Goh Lee Gan as a key advisor and contributor. The structure and components of the GDFM was reported in the previous Censors' Report. All the tutors underwent a 'Train-the-Trainer' programme to familiarise themselves with the programme. They were then linked with their trainees. During the launch of the programme, the trainees were paired with their respective trainers.

4 THE FIRST COHORT OF FELLOWS BY ASSESSMENT

The first batch of Fellows by assessment were assessed to have completed their programme after successfully traversing the final hurdle, the panel of interviewers for the exit interview on 16 September 2000. The Exit Panel consisted of an external interviewer, Prof Wes Fabb, A/Prof Goh Lee Gan, Dr Alfred Loh, immediate past President and Dr Lau Hong Choon, Censor-in-Chief. The assessment of the interview panel was that these doctors were worthy of the conferment of the FCFPS by virtue of their achievements and diligence in completing the two-year programme. Courses and Conferences

In recognition of the need for practical and relevant CME, the College launched a number of courses to provide value-added CME which will contribute directly to the practice of Family Physicians.

i) New On-line CME Programme Coming Soon

The College of Family Physicians Singapore and World Health Network Singapore have joined forces to provide general practitioners in the region with an on-line Continuing Medical Education programme. On 19 August 2000, Ms Rajul Patel, Director of World Health Network Singapore exchanged the memorandum of understanding with A/Prof Lim Lean Huat, President of CFPS.

World Health Network is an international organization that originated in the United Kingdom. It is better known to doctors in Singapore as the provider of the Healix (Health Intelligences Exchange) software. The Healix is a desktop reference which provide doctors with bulletins and updates of the latest in medical publications.

The programme is in a modular format that allows the participant to pace himself through a comprehensive syllabus that covers all the important areas in family medicine. The format of the modules is designed to be interesting and practice based.

Busy practitioners will now be able to refresh their skills and knowledge with much less time and effort. The latest and the most relevant materials are gathered, concentrated and presented in a refreshing format doing away with the old ways of waddling through irrelevant and boring materials that are presented in a haphazard manner.

The materials will be prepared and written by local specialists and general practitioners. Local doctors are more in tune with the CME needs of their colleagues. The emphasis is on transforming cutting edge medical developments into useful CME materials that are appropriate for physicians practising locally.

The advent of information technology has opened new ways of empowering physicians. This Continuing Medical Education programme aims to harness the power of information technology to produce good CME materials and make them readily accessible to our doctors.

ii) 5th Annual Surgical Update for Family Practice

This annual event was held at the Galleria Ballroom, Grand Copthorne Waterfront on 10 and 11 February 2001. The focus was on Aesthetic Surgery and Orthopaedic Trauma and related issues, followed by workshops.

iii) 2nd Minor Surgical Procedures Course For Family Physicians

Held in conjunction with the 5th Annual Surgical Update at the Singapore General Hospital on 17,18 and 25 February 2001. The Course had been extended to cater to more participants following the overwhelming response in the 1st course. This time the focus was on "Live Surgery" viewing with 2-way audio-video link between the course participants in the lecture room and the surgeons in the operating theatre on Day 1 and hands-on teaching sessions on Day 2.

iv) Public Forum on 'Public Myths about Cosmetic Surgery'

Also in conjunction with the Annual Surgical Update event, this forum was held on 10 February, 2001 at the Galleria Ballroom, Grand Copthorne Waterfront.

Following four years of negative balance, the College is finally in the black.

Income for the year increased by 27% to \$ 383,631 as compared to the previous year, while only 2% increase in expenditure was registered, resulting in a positive balance of \$ 32,747.

The collection from membership amounted to \$82,050, an increase of \$15,976 over the previous years, while income from various projects and activities (Item 15a - Miscellaneous income) was \$301,581, an increase of \$72,382.

Increased staff cost and high rental remained the two biggest expenditure as with previous years, while efforts to contain expenditures for the various projects and activities (Item 15b - Miscellaneous expenses), mainly by factoring them against sponsorships from pharmaceutical companies, lead to a cost saving of almost \$26,000.

The major activities organised this financial year yielded the following financial outcome:

The academic courses (FMTP, GDFM & FCFP) are generally well supported and remained profitable. High income yield this year for the Graduate Diploma in Family Medicine was due to the interests generated following its launch, and the fact that this is the first course, as well as to the omission of costing for the many man-hours expended by the Course Developers. Hence, we hope this trend and interests will be sustained for the next few years, to justify the tremendous effort put into the Course.

A deficit of *\$18,862 recorded for the 5th Annual Surgical Update For Family Practice was due to the late payment by the main sponsor, of \$15,700 (Paid after the financial year and not taken in), as well as cross-posting of income from advertisements and rental of exhibition booths (Both posted in Item 15a - Miscellaneous Income), and had actually resulted in the generation of a surplus of \$9,269.50 (See Attachment I: Income & Expenditure, 5th Annual Surgical Update For Family Practice). The Minor Surgical Procedure Course, having had its high capital cost (reuseable surgical models) expended last year, will continue to be lucrative.
