**MOH CIRCULAR 109/2009
INFLUENZA A/H1N1 (2009) VACCINES UPDATES**

Approval for children 6 months and above

1. **Panvax®**, **CSL** has now been approved by Health Sciences Authority (HSA) for children aged 6 months and above. The recommended dosing regime by HSA, endorsed by the MOH's Expert Committee on Immunisation, is as follows:

- a. **For children 10 years and above:** Single dose of 0.5 mL (15mcg). This is similar to the current adult dose recommendation
- b. **For children from 3 years to less than 10 years:** Two doses of 0.5 mL (15mcg), given at least 4 weeks apart.
- c. **For children from 6 months to less than 3 years:** Two doses of 0.25 mL (7.5 mcg) given at least 4 weeks apart.

2. An immune response that is expected to be protective against the Influenza A/H1N1 (2009) virus can be generated after 2 weeks of administering the first dose of vaccine. A second dose given at least 4 weeks later is needed in children less than 10 years of age to ensure that immunity is sustained.

3. The current single prefilled 0.5 mL syringe has a mark at the 0.25 mL level and may be used on children from 6 months to less than 3 years old to deliver half the dose. The first half of 0.25 mL should be purged out initially before the remaining half is administered. Under no circumstances should the same single dose syringe be used on more than one child. As the use of prefilled 0.5 mL syringe inevitably leads to vaccine wastage, it is recommended that children who need only 0.25 mL of vaccine should be preferentially vaccinated using the multi-dose vials, if available.

Availability and Cost of single prefilled 0.25 mL syringe

4. Single prefilled **0.25 mL syringes** will be available by end **January 2010**. The cost of a single prefilled 0.25 mL syringe is **\$12.00** (inclusive of GST). Please refer to **Annex A** for an updated comparison of H1N1 vaccines and **Annex B** for the revised Order Form.

5. The terms and conditions including requirements for notification and safety monitoring stated in MOH Circular 105/2009 (dated 29 October 2009) remains valid.
